If you receive \$500 or more in income from awards, prizes, lotteries, racetracks or raffles, you must file Form 502D - along with your full estimated tax payment - within 60 days of receiving the income. If you file joint returns, you and your spouse may file a joint Form 502D regardless of whether you file your final return jointly or separately.

Estimated tax is used to pay not only income tax, but other taxes such as self-employment tax and alternative minimum tax.
