Estimated tax is the method used to pay tax on income that isn't subject to withholding (for example, earnings from self-employment, interest, dividends, rents, alimony, etc.). In addition, if you don't elect voluntary withholding, you should make estimated tax payments on other taxable income, such as unemployment.

Corporate and Financial Institution Excise Vouchers these estimated tax payment vouchers provide a means for paying any current taxes due under Chapter 63 of the Massachusetts General Laws. All corporations and financial institutions that reasonably estimate their excise to be in excess of \$1,000 for the taxable year are required to make estimated payments.
