Unconditional Waiver and Release Upon Payment. An unconditional release is different from a conditional release because once you sign the document, you've immediately removed your right to file a mechanics lien or you're required to promptly remove an existing lien. An unconditional release means that there are no restrictions on the release of the lien.

Unconditional Waiver and Release Upon Final Payment

Use this form when the claimant is required to execute a waiver and release in exchange for, or in order to induce payment of, a final payment.

Unconditional Waiver and Release Upon Final Payment ...

Unconditional Waiver and Release Upon Final Payment means a written statement in the form attached hereto as to Exhibit F-3, containing a waiver and release of liens prepared and executed by Contractor or a Major Subcontractor, as applicable, pursuant to which a Person unconditionally waives and releases all mechanic's liens, stop notices and bond rights with respect to all Work.

Dependent on the contract requirements a subcontractor may request another subcontractor or material supplier to sign the Unconditional Mechanic s Release when that subcontractor has give payment.
